We are pleased to present you with the Annual Education Report (AER) which provides key information on the 2017-18 educational progress for Coon School. For the 2017-18 school year, schools were identified using new definitions and labels as required in the Every Student Succeeds Act (ESSA). A Targeted Support and Improvement (TSI) school is one that has at least one underperforming student subgroup. An Additional Targeted Support (ATS) school is one that has three or more underperforming student subgroups. A Comprehensive Support and Improvement (CSI) school is one whose performance is in the lowest 5% of all schools in the state. Some schools are not identified with any of these labels. In these cases, no label is given. Our school has not been identified as having been given one of these designations.

One key challenge for Coon School, as evidenced by the data contained in this report, is to increase achievement in Math. To achieve this goal the teacher and interventionist participated in a professional development series from the Kent ISD and Math Mathematics MichMe group on understanding the shifts in the Michigan Math Standards.

Coon School draws students from the surrounding Berlin Township area. Coon school is a single building that serves students in grades kindergarten through fifth grade. We also participate in the Schools of choice program and draw students from surrounding districts.

Coon School's 3-5 year school improvement plan is updated annually. Our goals focus on continuous improvement in the areas of reading, writing, science, social studies, and mathematics as we strive for each student to be proficient at their grade level and make at least one year of academic progress. Coon school is in the process of transitioning to the newly adopted State of Michigan Science Standards. Coon School currently utilizes the Michigan Grade Level Content Expectations for Social Studies.

5. THE AGGREGATE STUDENT ACHIEVEMENT RESULTS FOR ANY LOCAL COMPETENCY TESTS OR NATIONALLY NORMED ACHIEVEMENT TESTS

Coon School students continue to make adequate yearly progress in English Language Arts and mathematics. While we are pleased to have reached this important goal, we are continuously working to improve. We appreciate the continued support of parents, staff, and community in this effort.

6. IDENTIFY THE NUMBER AND PERCENT OF STUDENTS REPRESENTED BY PARENTS AT PARENT-TEACHER CONFERENCES

During the 2018-2019 school year, Coon School held parent-teacher conferences either in person or by phone in the fall of 2018 and the winter of 2019. The participation rate was 100%.

The staff at Coon School meets on a monthly basis in order to participate in timely professional development and school improvement. The purpose of these meetings is to ensure that the staff has the needed information and resources in order to meet the academic and social needs of all students in all grade levels. The staff also works closely with the special education personnel to make sure that the needs of all students are met.
